Any charges for customs inspection will be debited at cost

Any charges for storage, detention and demurrages will be invoiced at cost

Fumigation charges, import tax, duty, VAT, are not included

Sea freight

Transit Time is indicative and intended port to port

The custom clearance cost is intended as standard up to 3 HS codes, in case of any extra operation will be charged accordingly

Shipment is subject to shipping line acceptance

Shipment is subject to equipment availability

VGM and Solas requirements are at shipper's care and responsibility. Should however the shipper/exporter refuse to provide for the same (exw sales) our office is available upon mandate from the consignee to provide for the relevant task (container weighing per method 1 and VGM data transfer), at standard communicated costs

Exw/fob charges include one only custom operation and one only b/l set.

If rate is valid on prepaid condition only, please consider an advancing fee of 2% on freight amount (minimum USD 25) (For agents only)

Shipment subject to shipping line acceptance - eventual charges for demurrage / detention of IMO cargo at port terminal will be debited at cost .

Charges for plugs of reefer containers at ports will be debited at costs.

Shipment of open top /flat racks units are on deck at shipper's risk and subject to carrier's acceptance. Extra tarpaulin / covers are not included.

For groupage cargo the quote is valid for stackable goods only, not oversized / overweight.

For groupage quotations all the FOB charges have to be rounded to next higher unit.

During peak season the feasibility of cargo collection is subject to confirmation from our logistic department.

DAA, EUR1, CITES, other certifications, handling cost is not included in the standard export customs clearance charge.

Import quotes does not include import customs clearance, duties, vat, etc., demurrage and/or detention charges, eventual charges for customs inspection, waiting time, delivery in remote places and/or private residences.

For Import shipment, costs at departure, freight charges, duties and VAT will have to be paid in advance.

Air freight
